**FORM FOR NATURALIZED CITIZEN**

*I, Nickodem Wejnert*, a NATURALIZED AND LOYAL CITIZEN OF THE UNITED STATES, hereby apply to the Department of State, at Washington, for a passport, to be issued to me, accompanied by my wife, *Bernette*, born in *Langres, France* and son born in *U.S.A.* *little known*, *recreant*,  *Warsaw, Poland*.

I solemnly swear that I was born at *Germany* on *September 15, 1881*; that I emigrated to the United States, sailing from *Hamburg* about *July 1, 1907*; that I resided *13½ years*, uninterruptedly, in the United States, from *1907 to 1911* at *Hackensack, N.J.*

that I was naturalized as a citizen of the United States before the Court of *Hackensack*, on *June 19, 1917*, as shown by the Certificate of Naturalization annexed herewith; that I am the IDENTICAL PERSON described in said Certificate; that I have resided outside the United States since my naturalization at the following places for the following periods:

*Bergen County, Hackensack, N.J.*

*Paris, France*, from *July 1917* to *August 1918* that I am domiciled in the United States, my permanent residence being at *Hoffmann Ave., Little Ferry*, in the State of *New Jersey*, where I follow the occupation of *artist*; that I am about to go abroad temporarily, and intend to return to the United States within *8 weeks* *months* with the purpose of residing and performing the duties of citizenship therein; and that I desire a passport for use in visiting the countries hereinafter named for the following purpose:

*Poland* *Amsterdam, Holland* *Paris, France* *London, England* *British Isles* *Colombia, South America* *travel* *New York, U.S.A.*

I intend to leave the United States from the port of *New York* on board the *La France* on *about May 16, 1919*. My last passport was obtained from *Never had* and was *Nickodem Wejnert*.

**OATH OF ALLEGIANCE**

Further, I do solemnly swear that I will support and defend the Constitution of the United States against all enemies, foreign and domestic; that I will bear true faith and allegiance to the same; and that I take this obligation freely, without any mental reservation or purpose of evasion: So help me God.
